**Resolution 24-2025.** Motion by Tom Mooney, seconded by James Mooney to approve the minutes of the Regular April 7, 2025 meeting.

### ***Sewer-***

New Screen is installed and running great. The dump station engineering, permits and design will cost around \$165,000. ARPA funds can only pay for 10% of our grant amount towards those costs, so a 0% loan will be explained and discussed at the June 2025 meeting.

***Fiscal-*** A copy of April's Bank Rec and Fund Report are with your agenda. Group Fraud-Reporting Training Video Watched by all present.


### ***Old Business***


***New Business***
