Operational and Activity Data

- **Calls for Service and Arrests:** 2.
- **Incident, Investigation and Offense Reports:** 1
- **Traffic Enforcement:** All village roads have seen enforcement over the last month. Much of this time was spent on 88 on the village lines where places to park and operate stationary radar are more practical. 3<sup>rd</sup> street had a heavier presence in October while operating radar while moving.

- **Use of Force Incidents:** No use of force
- **Public Contacts:** On October 22<sup>nd</sup> I was forwarded an email from Mayor McIntosh in reference to speed in the village, specifically in the areas of High Street, 2<sup>nd</sup> and College St. The email asked for officers to be present during bus pick up and drop off times. This email was forwarded to the department, and officers were asked if they could cover any of these times. Additionally, contact was made with Ohio State Highway Patrol to seek any additional units during these hours as well as the Sheriff's Office due to the unique and daily occurrence of these bus times. At the time of this report no response from either agency has been made.

#### Departmental Management and Resources

- **Equipment and Needs:** Condition of vehicle remains unchanged. Tires will be needed and quotes from at least 3 different sources are forthcoming.
- **Personnel Matters:** Our staffing level is unchanged, training emails have been received from the Attorney General's office on CPT due by the end of the year (24 hours) This CPT training is specific and other required trainings do not fall under these 24 hours required block. Certifications on departmental equipment, firearms, less lethal, programs and other resources training requiring certification cannot be counted towards these 24 hours.

#### Community and Legal Matters

- **Complaints and Disciplinary Actions:** Pending Leads Audit not completed, Ian Miller from Leads has contacted me requesting closure on our August 2025 Audit that requires documentation from our agency TAC, Sgt. Bittner. This has not been received, and he was advised by Sgt. Bittner that she was on medical leave.
- **Public Records and Transparency:** Records requests for the month of October have been answered and emailed to the requestor without further requests needed.
- **Special Operations or Initiatives:** The Small Ohio Police association has been constantly providing us with resources for training throughout the year and this information is forwarded to the department. Many are free and some have been able to meet CPT requirements. The downside to these trainings are that they might be in Columbus or further south.

Contingency monies left were given to Council for review.


