Shipping containers

Definition of a shipping container is a standardized reusable steel intermodal container commonly used for the storage and movement of materials and products in a global containerized freight transport system. Other names include container, storage container, freight container, cones box, and sea shipping organization (ISO) container, cargo container, hi-cube container, Conex box and sea can.

"Intermodal" indicates that the container can be moved from one mode of transportation to another. Shipping containers do not include Portable on Demand Storage (PODS), truck trailers, vans, converted mobile homes, converted recreational vehicles, school bus bodies or vehicular transport truck box enclosures which have been manufactured as an integral part of the vehicle, or which have or had permanently affixed wheels and any similar prefabricated structures originally built for purposes other than the storage of goods and materials.

1. Shipping containers as storage

- A. Shipping containers (truck trailers) can be used as permanent storage. Can not be used for human or animal occupancy (no sanitary facilities or kitchen facilities).
- B. Must be painted within 30 days of placement. Solid colors of tan, black, gray, or dark green, or color of house. No fluorescent colors.
- C. Must be set level on paved, gravel or concrete pad. Subject to the same setbacks as accessory buildings.
- D. No more than two (2) behind main residence. Must be 30 feet behind main residence, 20 feet side property line and 20 feet rear property line.
- E. The owner shall keep all equipment functional, painted and in good working order.
- F. The owner will have 180 days to remove the container when it reaches end of life as deemed by village zoning.
 - G. No stacking, one (1) level only.
- H. Shipping containers will be considered as accessory buildings for storage purposes only and will require a permit. Permit fee to be determined by zoning inspector per container.

- I. The use of PODS units on residential property for temporary storage to load or unload for moving is permitted for no longer than 120 days in a year and is not included in these regulations.
 - J. Shipping container as storm shelter
 - 1. A container may be buried for only the pose of a storm shelter. To follow all State of Ohio and Trumbull County Building Codes. It can be placed in a basement or under a garage.
 - 2. If not buried, must follow all regulations as if it were placed on the surface of the ground for the Zoning District where it is.
 - 3. Must have inside and outside access for emergency access.
