- OPOTA Continued Professional Training (CPT) email
- “Pursuant to ORC 109.803, Ohio peace officers and troopers are required to complete continuing professional training each calendar year. Our records reflect peace officers or troopers at your agency have not yet completed all of the required 24 hours of CPT for this year.

We are sending automated reminders to all agencies that the CPT completion deadline for this year is rapidly approaching.

If your agency has not certified that each of these officers have completed the required CPT by December 31st of this year or been granted an extension by the Executive Director for a permissible reason, they will enter 'Cease Function' status as of January 1.

At that time, officers in cease function status must cease carrying a firearm and performing all law enforcement functions.”

This Department will take advantage of the training as it presents itself at a price that is at no cost for the Village. Not all training will be accepted under the guidelines listed in the email.

Firearms training cannot be counted for CPT – On October 14th 6 officers requalified on their duty firearms at no cost to the village. Although not a CPT requirement it is a requirement to qualify every calendar year. An indoor range and ammo were provided by LT. Ballway again at no cost to the village.
